

The probate seminar manual will only be available at **www.trumbullprobate.org** one week prior to seminar to download or print. No Wi-Fi will be available at seminar.

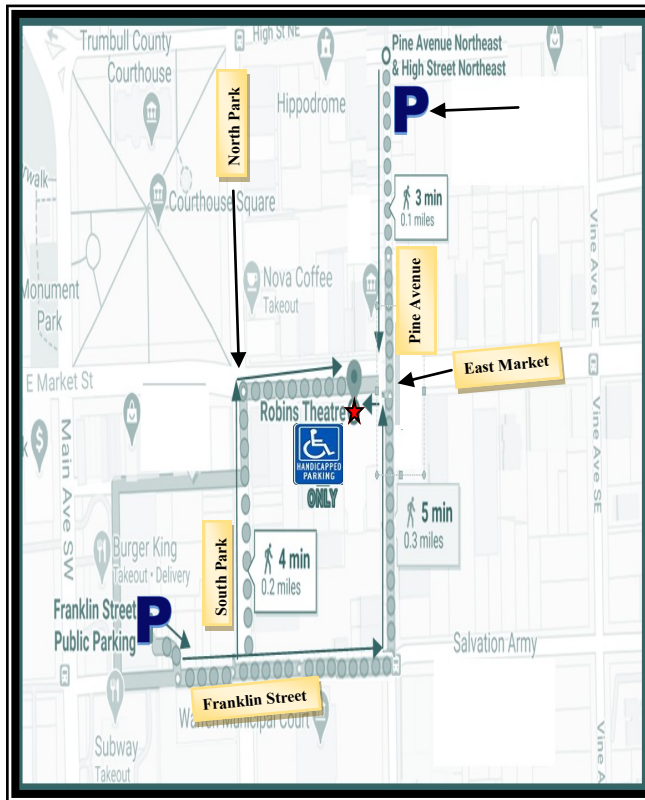
